As regards Public Examination Fees, these are chargeable to parents and will normally appear in the termly invoice for the term in which the examination is taken.

All incidental charges are itemised on the termly bill.

Fees are reviewed normally on an annual basis with increases approved by Governors implemented from the Autumn Term of the Academic Year.

Fees are billed on a termly basis, in advance.

VAT on School Fees
